Clinton A. Fultz is the owner and principal broker of Prime Site Brokers, Inc. Prime Site Brokers was formed in November 2003 and is located in Indianapolis. Mr. Fultz started his career in the real estate in 1982. He began selling residential real estate on the west side of Indianapolis and has worked with commercial properties since 1986. Prior to forming Prime Site Brokers Mr. Fultz spent 3 years with The Linder Company (then Sitehawk, now CBRE) and 4 ½ years at RE/MAX Commercial Group. Mr. Fultz operated Venture Realty from 1991-1995. He was with Century 21 Concept prior to 1991.

CCIM is given to a select few commercial Realtors in recognition of having completed an extensive list of classes and tests, plus proven real estate experience and deal making ability. In 2003 he was the lead partner of a group that bought and repositioned an old Cub Foods store near Lafayette Square Mall into a 14 screen stadium seating movie theatre and Sav-A-Lot grocery. He is the sole owner or a major partner in over 350,000 SF of commercial real estate. Major brokerage transactions include the AMC Theatre at Castleton Square Mall, land purchase for the new Eastbrook Elementary of Pike Township Schools, a medical building in Intech Park and the acquisition of property for Indiana University Radiology on the downtown Indianapolis canal. In 2014 he purchased the former Walgreens at 7911 Michigan Road, Indianapolis. After renovationsw and re-tenanting it was sold for a substantial profit.

In 1993, 1999, 2004 and 2008 Mr. Fultz won the "Exchanger of the Year" award from the Indiana Real Estate Exchangors (IREX) for his work in completing complex and difficult tax deferred exchanges of investment property. He was also honored by IREX in 2000 and 2006 with the Wechsler - Smock award for outstanding service to the organization. He was President of IREX in 1995, 2003, 2013 and will be President in 2020.
